Reason – Lack of members and volunteers CRSG, beneficial for only 1 group to require some insurances, more members at CRHG so taken more seriously by the local Shire and Community. The CRSG was formed away from the CRHG in 1998, but both are part of the Collie Rail Precinct. The station <u>land</u> lease with the Shire of Collie expires 30 June 2023. Assets – building, Bendigo Bank shares, bank account and cash on hand (float/petty cash), stock on hand (stocktake required), museum, cafe & library items.
